Summary of Rhode Island's Federal Authorities Requests in Response to COVID-19

The Rhode Island Executive Office of Health and Human Services (EOHHS) has sought numerous federal authorities to make necessary, temporary changes to the Medicaid program to ensure that Medicaid members continue to receive medically necessary services covered by Medicaid while minimizing exposure to the Coronavirus Disease (COVID-19). This document describes the requests that were sent to the Centers for Medicare and Medicaid Services (CMS). Please note the approval status in the fourth column. <u>Not all requests have been approved for implementation</u>. Prior to implementation, these changes need to be approved by CMS, the Governor's Office, and the Office of Management and Budget (OMB).

EOHHS does not intend to carry these authorities forward after the termination of the COVID-19 emergency declaration. The existing RI Comprehensive 1115 Demonstration Waiver will remain in force unless described in the emergency federal authority requests.
